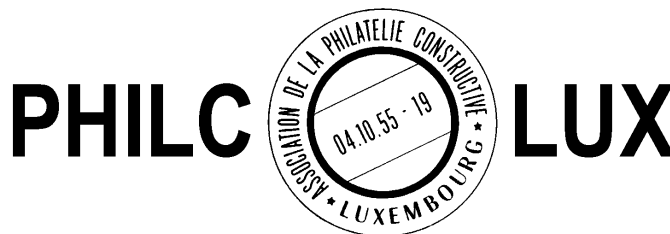

## Participation terms and conditions EXPHIMO 2020

1. EXPHIMO is the yearly official thematic stamp exhibition of the Luxembourg Philatelic Association (FSPL). The responsible organizer is the thematic stamp collector club PHILCOLUX.
2. The EXPHIMO 2020 (62nd edition) will have the topic „Technology" and the '1-Frame team Competition for philatelic groups and communities'. The organization is done in close collaboration with VPhA and the international thematic groups of the same topic. The exhibition is therefore mainly dedicated to exhibits of the named topic and one frame collections. The EXPHIMO does not foresee a youth class.
3. The exhibition comprises the following classes:
  - VPhA 1-frame Team Competition
  - Thematic competition class Technology
  - Technology class without competition
  - Thematic Open philately
  - one frame thematic competition class
  - general thematic competition class
4. The exhibition takes place on the Pentecost weekend from **Saturday May 30th, 2020 until Monday June 1st, 2020 inclusive at the Centre Sportif „Roll Delles “, avenue des Villes Jumelées L-5612 Mondorf-les-Bains.**
5. The registration using the special registration form with a copy of your exhibitor pass must have been sent until the 31.12.2019 to Mr. Roger THILL, 8A rue du Baerendall, L-8212 Mamer or Mister Hans-Gerd Treschnak, Klaus-Funke-Str. 14 D-58675 Hemer for the 1-Frame Team Competition (until 15.02.2020).
6. The EXPHIMO is a national exhibition with international participation. The exhibits of the competition classes will be evaluated by applying the FIP conditions for thematic exhibits. Exhibits which do not fulfil these conditions will not be evaluated and receive only a participation certificate. An Exhibit which is registered for one of the competition classes must comprise at least 3 frames (1 frame = 15 pages <https://philcolux.lu/Cadres.pdf>). A prior award for the access to the EXPHIMO is not required. Exhibits that have received gold award at a FIP exhibition will not be accepted for the competition classes. Each exhibitor has to be member of a stamp collector club or of a thematic stamp collector group, which is member of the FIP through its national stamp association.
7. The international EXPHIMO – jury is comprising preferably at least one member who is a specialist of the exhibition topic. The decisions of the jury are definitive and without any right of veto. The jury will start the evaluation of the exhibits on the evening of Friday 29th May 2020. The exhibits have therefore to be present at the exhibition on Friday 29th May at 17:00 h at the latest.
8. Each exhibitor of a competition class receives a prize and a diploma in the grade of the award received (Medal). Exhibitors from Luxembourg must have provided their exhibitor pass prior to the evaluation. Foreign exhibitors can choose if the evaluation should be registered in their exhibitor pass. In both cases the exhibitor pass must be available to the exhibition manager or to his deputy on Friday May 29th.
9. The exhibits must not comprise issues whose exhibition is contrary to the FIP regulations of harmful or unwanted issues.
10. Only the pages shown in the exhibition frames will be accepted. Each page must be included in a transparent protective cover.
11. The participation and registration fees amount to 10 Euros per frame. This amount has to be paid within 2 weeks of the definitive notification of the allocated number of frames. The organizer PHILCOLUX bears these costs for the exhibitors which are Luxembourg residents (of Luxembourg nationality and foreigners) and who are member of the FSPL.
12. The exhibitor has to pay the shipping costs for the transport to destination. For the re-consignment, we will charge a flat rate of 30 Euros. Residents of Non CEPT countries will be charged 60 Euros. The exhibits from countries outside the European Union must be exported through the same way as they have been imported to Luxembourg. The personal delivery and return by the exhibitor or his deputy is highly recommended.
13. There is a possibility to insure the exhibit for the duration of the exhibition through the organizer. The premium for his insurance to be paid by the exhibitor amounts to 1% of the declared nominal value of the exhibits. The organizer foresees the best possible protection of the exhibits. The organizer declines any responsibility in case of loss, damage or theft for exhibits which are not insured through the organizer and this during the delivery and return, the installation, the duration of the exhibition and the dismantling of the exhibits. The organizer PHILCOLUX bears the insurance premium for the exhibitors who are Luxembourg residents and who are member of the FSPL.
14. The organizational committee will decide on every point which is not covered by the above conditions.
15. By signing the registration form, the exhibitor accepts and respects the above conditions.
16. The EU data protection regulation 2016/679 from May 25th, 2018 will be respected.
